As you requested, the following information is provided with regard to the accreditation status of Daybreak University (DU) with Transnational Association of Christian Colleges and Schools (TRACS).

The Transnational Association of Christian Colleges and Schools (TRACS) is recognized by the United States Department of Education (USDE), the Council for Higher Education Accreditation (CHEA) and the International Network for Quality Assurance Agencies in Higher Education (INQAAHE) as a national accrediting body for Christian institutions, colleges, universities, and seminaries offering certificates, diplomas, and associate, baccalaureate, and graduate degrees as well as distance education.

At its meeting on October 27, 2020, the TRACS Accreditation Commission voted to grant Daybreak University (DU) Accreditation status as a Category IV institution approved to offer the following degree programs with the noted specializations:

Daybreak University is approved to offer its courses and programs via Distance Education.

It is noted that Daybreak University has added instruction language. The instruction to the whole class is in Korean and English.

For Reaffirmation I, DU must complete a successful Self-Study, host an Evaluation Team Visit, respond to the team's Findings, Recommendations, and Suggestions, and appear before the Accreditation Commission by Fall of 2025. The Accredited Status is retroactive to the first day of the 2020 Fall Term or Semester for your institution. This is in accordance with TRACS Board Policy BP305.
